INVESTMENT AND RETURN OBJECTIVE

The Fund aims to provide an income from dividends that is greater than the FTSE/JSE Africa Shareholder Weighted Index by investing in shares that offer an attractive yield relative to the benchmark. It further aims to outperform the benchmark over the long-term.

INVESTMENT PROCESS

The Fund uses quantitative techniques to build a high income equity portfolio which aims to deliver superior dividend income and performance relative to its benchmark. The selection process targets those shares that offer an attractive dividend yield but screens out high dividend yield shares that is out of favour. A further screen ensures that the portfolio is scalable and maintains high liquidity.

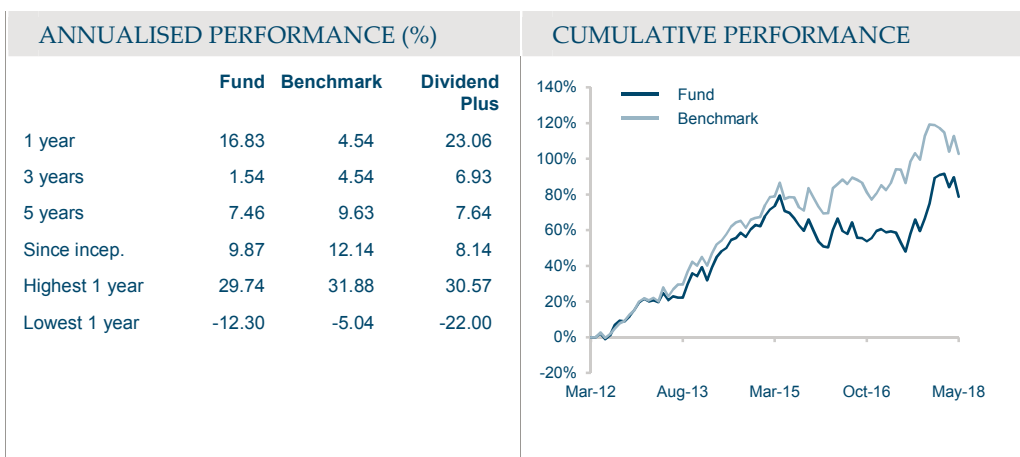
WHO SHOULD INVEST

Investors with a long-term investment horizon seeking broad based exposure to higher dividend yielding stocks in the South African equity market.

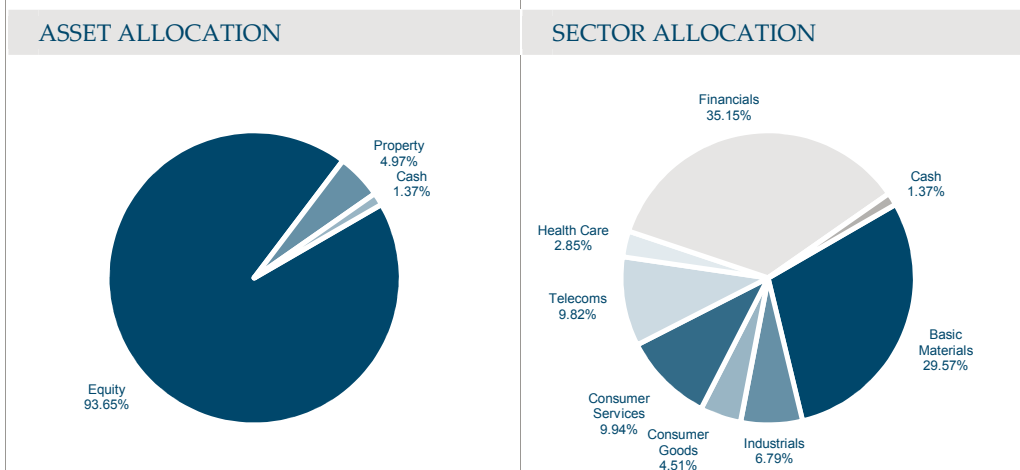
RISK INDICATOR DEFINITION

FUND COMMENTARY

European equity markets experienced significant selling pressure after political parties in Italy became entangled in a power struggle between Eurosceptic populists and the remaining pro-EU establishment politicians. The prospect of rising popularity of populism after Italy's lackluster economic performance over the last while and President Sergio Mattarella (pro-EU and pro-austerity) controversially rejecting a deal where the proposed finance minister was a Eurosceptic, heightened fears that a populist party would lead Italy outright. The MIB index dropped by a mammoth -9.15% whilst the CAC40 index lost -2.21%. Meanwhile, US equity markets rose with the S&P500 and the Dow Jones Industrial Average indices added 2.16% and 1.41% respectively in May. Risk-off sentiment resulted in cash moving out of emerging markets. The JSE All Share index therefore struggled and lost -3.48% over the month. Financial shares were the main detractors. Amidst foreign outflows, South African's 10Y Government Bond sold off with its yield ending 0.37% up at 8.75%. Much the same, the All Bond index lost -1.95% in May in a rising interest rate environment. Increased risk meant higher demand for safe haven assets. As such, gold ended 0.74% up at USD1305/ounce whilst the 10Y US Treasury Bond rallied with its yield falling from 2.96% to 2.87%.

The Prescient Equity Income Fund, which follows an investment strategy that seeks high yielding shares that also have favorable market sentiment, lost -5.66% in May and this was behind both the Divi+ index (-4.64%) and the broader SWIX (-4.73%). The Fund's sector exposure still favors Financials, Basic Materials (the bulk of which is high dividend yielding Kumba Iron Ore) and Telecommunications relative to the benchmark. Conversely, it is underweight Consumer Services (the majority of which is concentrated in Naspers) and Consumer Goods.

Contributors to Performance

The positions that contributed most to the performance of the Fund were the miners with Kumba Iron Ore (+8.05%), Billiton (+8.63%) and Exxaro (+12.62%) on a total return basis.

Detractors from Performance

The largest detractors from performance were MMI Holdings (-15.96%), Foschini (-3.91%) and Barclays Group Africa (-11.65%) on a total return basis.

It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.

GLOSSARY

Annualised performance: Annualised performance show longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

Alpha: Denoted the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Dividend Yield: The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

PE Ratio: The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.
