MINIMUM DISCLOSURE DOCUMENT

INVESTMENT AND RETURN OBJECTIVE

The Fund aims to provide equity-like returns over the long term while aiming to have negative drawdowns that are lower than the equity market over the shorter term.

INVESTMENT PROCESS

The Fund replicates the FTSE/JSE Top 40 index by using futures. A derivative overlay is then applied to the synthetic equities to negate the downside risk associated with equities. The protection levels of the derivatives will differ as the cost of protection differ during different market conditions.

WHO SHOULD INVEST

Investors with a long term investment horizon who are seeking real growth but have less appetite for equity market volatility.

RISK INDICATOR DEFINITION

These portfolios typically have moderate equity exposure and exposure to offshore markets which may result in capital volatility over the shorter term. They are managed in such a manner that the probability of double digit capital losses over one year periods is unlikely. These portfolios typically target returns in the region of 4% - 5% above inflation over the long term.

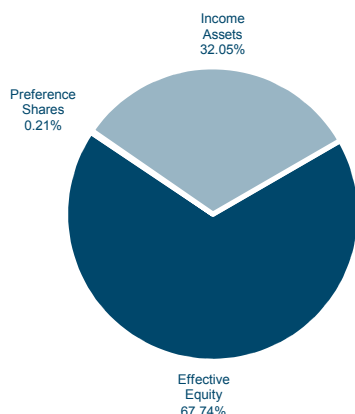

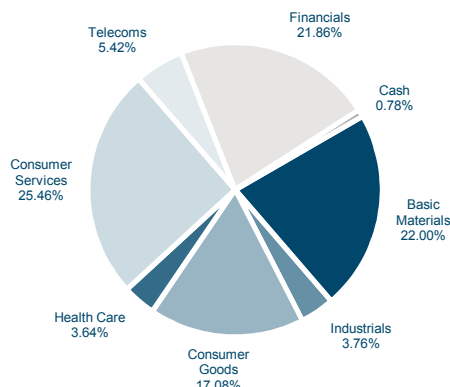

FUND COMMENTARY

All major asset classes ended August slightly stronger. The strategy managed to outperform cash, bonds and property, however, underperformed the equity market. The level of implied volatility still didn't manage to stabilise and continued its grind lower. Protection therefore is once again cheaper than it has ever been. While this has been a drag on performance over the last couple of months, it creates opportunities going forward.

Most of Reserve Bank Commentary at the recent Jackson Hole Conference was filled with dovish talk. Added to this, the continuously strong macroeconomic data helps to paint a positive picture for equities. However, elevated valuations, a business cycle which is already very long in the tooth, complacent market participants as well as our anticipation of tighter monetary policy going forward, encourages us to remain cautious. Our equity exposure therefore continues to be low, always fully protected close to current market levels. This positioning enables us to capture equity upside whilst at the same time, being protected on the downside at all times. The ever lower cost of protection presents an opportunity to access equity upside without taking on too much risk to significantly underperform cash during periods of market falls.

Contributors to performance: Equities, property and income positions added value during August.

Detractor from performance: On the contrary, the protection overlay detracted value in August as markets moved higher and volatility continued to drop.

GLOSSARY

Annualised performance: Annualised performance show longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

Alpha: Denoted the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Sensitivity Analysis: Shows the expected return of the Fund for the Performance Projection Period (label on vertical axis), at the end of the Performance Projection Period based on a range of potential moves in the equity market from this month-end to the end of the Performance Projection Period.
