The Fund is a property index fund where returns are enhanced by taking advantage of low risk arbitrage opportunities in the market. Additional benefits are gained from efficient implementation of cash flows, dividend reinvestments, management of corporate actions and index rebalancing. The Fund aims to remain fully invested in property shares at all times.

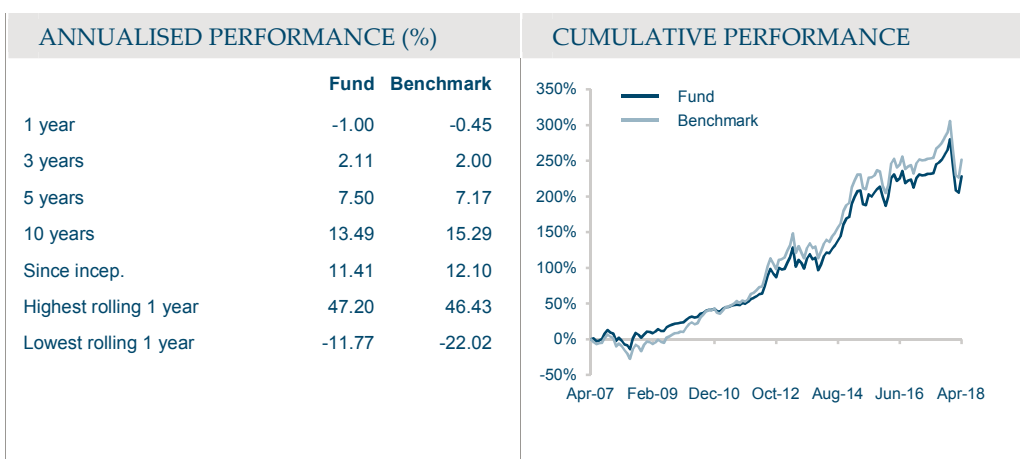
WHO SHOULD INVEST

Investors who require exposure to SA listed property shares and who are comfortable with the volatility and potential short term capital losses that can result from exposure to property shares.

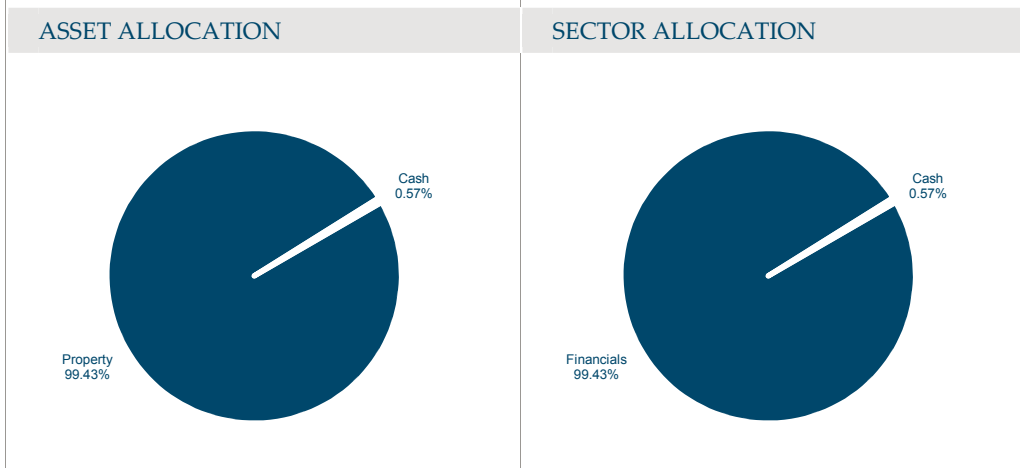
RISK INDICATOR DEFINITION

FUND COMMENTARY

Equity markets staged an impressive rebound in April. After fears of a global trade war sparked between the US and China, a sixty-day extension in the negotiating period between those two countries was agreed. This lifted sentiment as it was deemed to be more than enough time for the world's two largest economies to see eye to eye on a suitable trade policy deal. European markets were buoyed most by the extension with the DAX and CAC40 indices rising 4.26% and 6.84% respectively. Meanwhile, US markets were somewhat more subdued with the S&P500 and Dow Jones Industrial Average adding only 0.19% and 0.34% respectively. Bond markets struggled amidst higher inflation expectations in the US. Despite inflation expectations there simmering for the last while, Brent crude oil adding 7.58% over the period was most likely the straw that broke the camels back and led to higher interest rate expectations around the globe. The JSE All Share index rose by 5.40% with the resource board (+9.37%), which rallied in line with the oil price, making the largest contribution. Speculative activity in the property sector also seemed to disappear with the property board returning 7.62%. Interest rate expectations domestically however, took their cue from international expectations with the yield of the SA 10Y government bond rising by 0.19% to end at 8.18%. Hence, domestic bonds struggled with the ALBI losing -0.66% in April.

The property index also rebounded with the benchmark ending the last month up +7.62%. The Prescient Property Equity Fund returned +7.63% for the month, which was slightly ahead of the benchmark.

Contributors to Performance

The positions that contributed the most to performance were Neppi RockCastle (+19.64%), Resilient (+35.50%) and Fortress REIT Ltd (B) (+46.22%).

Detractors from Performance

The largest detractors from performance were Attacq (-2.48%), Arrowhead Properties (-3.58%) and SA Corporate Real Estate (-2.05%).

During the phase in period TERs do not include information gathered over a full year. Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction cost is a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.

Where a current yield has been included for Funds that derive its income primarily from interest bearing income, the yield is a weighted average yield of all underlying interest bearing instruments as at the last day of the month. This yield is subject to change as market rates and underlying investments change.

GLOSSARY

Annualised performance: Annualised performance show longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

Alpha: Denoted the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Dividend Yield: The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

PE Ratio: The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.
