MINIMUM DISCLOSURE DOCUMENT

INVESTMENT AND RETURN OBJECTIVE

The Fund aims to achieve returns above the FTSE/JSE Africa Shareholder Weighted Total Return Index (SWIX). The equity selection is done purely on a bottom-up basis and risk is actively managed in the portfolio construction process to eliminate undue stock specific risk.

INVESTMENT PROCESS

The Fund uses quantitative techniques (multi-factor model) to build an active equity portfolio. The selection process targets those shares that offer the best economic value according to predefined income statement, cash flow statement and balance sheet matrices. The quantitative process maintains some positive index type characteristics, such as low turnover and thus lower cost and high liquidity.

WHO SHOULD INVEST

Investors seeking broad based exposure to the South African equity market. This Fund is appropriate for investors with a long-term investment horizon.

RISK INDICATOR DEFINITION

These portfolios typically hold meaningful equity and/or offshore exposure which may result in significant capital volatility over all periods. Due to their nature expected long term returns are higher than for the other risk categories.

FUND COMMENTARY

The South African economy has desperately underperformed major global economies over the past year. This became abundantly clear with the negative GDP prints in both 2016 Q4 and 2017 Q1, sending South Africa into a technical recession. We still await a GDP print for Q2, but South African economic activity has picked up pace in recent months. The main signs of a South African recovery come from new vehicle sales, electricity production and real credit extension.

Local markets raced out of the 2017 H2 starting blocks with even greater enthusiasm than they did in H1. The Top 40 index leaped by 7.65% in July.

The Fund returned 5.99% for the month and ended marginally behind the benchmark, which returned 6.34%.

Contributors to Performance:

The positions that contributed most to performance were an overweight in BHP Billiton (20.01%) and Gold Fields (17.92%) and an underweight in British American Tobacco PLC (-7.64%), Steinhoff International Holdings (-1.57%) and Barclays Africa Group Ltd (0.59%).

Detractors from Performance:

The largest detractors from performance were an underweight in Naspers (14.28%) and an overweight in PPC Ltd (-9.83%), Invicta Holdings (-7.76%), Tencor Ltd (-4.84%) and Redefine International PLC (-3.12%).

During the phase in period TERs do not include information gathered over a full year. Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction cost is a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.

Where a current yield has been included for Funds that derive its income primarily from interest bearing income, the yield is a weighted average yield of all underlying interest bearing instruments as at the last day of the month. This yield is subject to change as market rates and underlying investments change.

GLOSSARY

Annualised performance: Annualised performance show longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

Alpha: Denoted the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Dividend Yield: The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

PE Ratio: The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.
